Relative(s)	Only includes familial relatives or those related to a child by marriage,
	adoption, or guardianship.
Fictive kin	Persons who are not familial relatives of the child or related through marriage, adoption, or guardianship but have a relationship with the child or child's family including godparents, close friends, neighbors, and others.
Kinship caregiver(s)	Kinship caregivers are relatives or fictive kin caring for children no longer in the physical and/or legal custody of their parent(s) with or without child welfare agency involvement.
Parent(s)	Parents include birth parents, adoptive parents, or legal guardians.
Facilitated kinship caregiving arrangement	This refers to an arrangement that a caseworker facilitates between a kinship caregiver and child when the child comes to the attention of the child welfare system and a caseworker has concerns about the child's safety but the child is not removed from the legal custody of their parent(s).

Fostering Connections to Success and Increasing Adoptions Act of 2008	Enacted in 2008, this act amends Title IV-B and Title IV-E to increase supports for and connection with relative caregivers of children in foster care among other provisions to improve outcomes for children in care. <sup>1</sup>
Family First Prevention Services Act of 2018 (FFA)	Enacted in 2018, this act provides new federal funds for prevention activities through Title IV-E for states that develop an approved prevention plan with a focus on mental health supports, substance use treatment, and improved parenting skills. <sup>2</sup> It also provides for ongoing federal reimbursement for kinship navigator programs that meet evidence-based standards.
